Tanpa sokongan daripada Pengarah Rela kelulusan tidak boleh diberi dan kelulusan lesen adalah bertaraf setahun ke setahun. Ini adalah untuk memastikan supaya ahli Rela yang mendapat lesen untuk membawa dan menggunakan senapang patah adalah yang telah dipilih oleh pihak Rela sendiri.

2. Amalan terdahulu di mana semua ahli Rela boleh diberi lesen dan menggunakan senapang patah telahpun menimbulkan beberapa kemusykilan berkenaan dengan penjagaan senapang.

OFFICIAL MEMORANDUM

SUBJECT: Licences to Carry and Use Shotguns for RELA Members
REF: PKM/235/8 DATE: 26th November, 1981

I am directed to inform you that under the Arms Act, 1960, all members of the Ikatan Relawan Rakyat (RELA) are required to be in possession of a licence to carry and use shotguns owned and issued by the RELA. The licence fees are exempted under the Shotguns and Ammunitions (Licence Fees) (Exemption) Notification, 1979 vide Gazette No. Swk.L.N.(F)2 dated 11.1.1979.


2. The Pengarah, RELA Sarawak is issuing an instruction to all the RELA field officers on this and will submit applications for licences to carry and use shotguns to the District Officers concerned on the appropriate forms together with 2 copies of their photographs. In submitting such application, ~~the warrant cards of the members will be produced as evidence to show that the applicants are genuine RELA members.~~

3. All District Officers are, therefore, requested to issue licences to the RELA members as and when their applications are submitted.

4. As the shotguns issued to the RELA members are transferable and being changed from time to time and also as the use of the shotguns is shared by them, the licences issued should not specify a particular shotgun to be carried and used by a particular member. What is required in the licence is to state that the licensee is authorised to carry and use shotguns owned and issued by the RELA from time to time.

5. If and when the licensee ceases to be a member of RELA, the Pengarah, RELA Sarawak has made arrangement to ensure that the licence to carry and use shotguns issued to him will be withdrawn and surrendered to the issuing authority.
